2024 BASE RATE RELATE BACK SURCHARGE RIDER

I. PURPOSE

This 2024 Base Rate Relate Back Surcharge Rider ("2024 BR-RBSR") recovers Entergy Texas, Inc.'s ("ETI" or "Company") increase in base rate revenues as approved by the Public Utility Commission of Texas ("Commission") in Docket No. 53719. As provided in 16 TEX. ADMIN. CODE ("TAC") § 25.246(d), the approved base rates shall be made effective for consumption on and after the 155th day after the date the rate-filing package is filed at the Commission. ETI's base rate increase takes effect, or relates back, to December 3, 2022, which is the 155th day after ETI's rate application in Docket No. 53719 was filed. The 2024 BR-RBSR gives effect to the December 3, 2022 relate-back date and recovers the base rate revenues that would have been recovered had the approved base rates been in effect between December 3, 2022 and June 2, 2023 (the date the base rates were approved on an interim basis in Docket No. 53719).

II. APPLICABILITY

This rider is applicable to electric service provided by the Company to all customers served under applicable retail rate schedules set forth in Attachment A to this rate schedule, whether metered or unmetered, subject to the jurisdiction of the Commission.

III. 2024 BASE RATE RELATE BACK SURCHARGE RIDER COST RECOVERY RIDER - RATES

The rates associated with this 2024 BR-RBSR shall be as set forth in Attachment A to this rate schedule, and were calculated by application of the Commission-approved increase in base rate revenues distributed across customer classes as approved in Docket No. 53719.

IV. TERM

Subject to the provisions of 16 TAC § 25.246(d), this 2024 BR-RBSR shall remain in effect until the termination date.
